## **Report of the Performance Committee**

#### **Executive Session**

Kathy reported on the Executive Session at the last MSWTC Board meeting on September 7<sup>th</sup>. Kathy shared that she sent our club's membership application to the Welsh Terrier Club of Northern Illinois (WTCNI) as planned. She received a reply which indicated the WTCNI could not give a specific date when a merge could occur. After a discussion, the board voted to rescind the membership application and move forward with obtaining are own AKC club certification. Kathy said the board is actively working on the application process. Kathy also addressed the eventual requirement to adopt a region-specific name for our club that requires AKC approval.
