### **Introductory Remarks**

The meeting was called to order at 7:02 PM EST by Kathy Rost. Kathy welcomed all Zoom participants.

### **Minutes of the Last Meetings**

Minutes from the 10.18.2021 general meeting were presented. Pam Allen made a motion to approve the minutes and Daryl Peters seconded the motion. The minutes were unanimously approved.

### **Report of the President**

She also said that a *Ringside Etiquette* guide is under development and there are plans in the making to offer an educational program on *Emergency Planning* to help individuals and breeders to be better prepared in the event of a crisis or unforeseen situation compromising animal care. Mary also said there are plans for a live program on Welsh terrier breed type in Louisville.

### **Report of the Performance Committee**

Daryl and Janice are co-chairs of this committee. Daryl reported there 16 Welsh Terriers from the WTCNI at the Fast CAT Meet-up at the K9 Splash Zone in Brookville, Ohio on October 23<sup>rd</sup> and 24<sup>th</sup>, with four dogs awarded titles. Daryl said that the Motor Cities Fox Terrier Group, in conjunction with the Terrier Club of Michigan, will be having Earthdog testing on April 16<sup>th</sup> and 17<sup>th</sup>, Fast CAT September 17<sup>th</sup> and 18<sup>th</sup> and Earthdog testing on September 24<sup>th</sup> and 25<sup>th</sup>.

### **Report of the Hospitality Committee**

Cathy reported that she has been in communication with Charles Yorke and Jeff Whitney as the WTCA and the WTCNI are working together to coordinate hospitality details for Louisville. Cathy has been in contact with management from the Bravo! Italian Kitchen for the WTCA/WTCNI dinner planned for Saturday, March 19<sup>th</sup>.
