In the article by **N. A. Kiselev** and **L. L. Kiselev**, “Electron Microscopy of Soluble Ribonucleic Acids,” published in *DAN*, vol. 141, no. 4, 1961, the caption to Fig. 1 should read as follows:

Fig. 1. **A** –S-RNA from wheat germ in acetate-ammonium buffer ($\mu = 0.16$); 130 000 \times ; ratio of object height to shadow $1 : 7.5 \pm 1$. **B** –S-RNA from yeast ($\mu = 0.15$); 130 000 \times ; ratio of object height to shadow $1 : 7.6 \pm 0.5$. **C** –S-RNA from yeast in water ($\mu = 1 \cdot 10^{-5}$); 200 000 \times ; ratio of object height to shadow $1 : 8.4 \pm 0.5$.

In the article by **A. Sh. Faitelson**, “The Riga Pre-Devonian Depression,” published in *DAN*, vol. 140, no. 1, 1961, the caption to Fig. 1 should read: Contour of the Riga Pre-Devonian depression.

In the article by **V. V. Petrov**, “On Integral Theorems for Large Deviations,” published in *DAN*, vol. 138, no. 4, 1961, the following corrections must be made:

On p. 779, line 7, the printed text

$X_1, X_2,$

should read:

X_1, X_2, \dots

On p. 779, line 13 from the bottom, the printed text

$$\frac{s}{2(s+3)} < a$$

should read:

$$\frac{s}{2(s+2)} < a.$$

In my article (**L. G. Mikhailov**, “On a Boundary-Value Problem for a Linear System”), published in *DAN*, vol. 139, no. 2, 1961, on p. 294 in Theorem 1 the condition $|a(t)| > |b(t)|$ was omitted, and on p. 297, line 8, in the expression $G(t)$, instead of $[b_1(t) - b_2(t)]$ it should be $[b_1(t) - a_2(t)]$.
