CORRECTION

In my article (M. A. Veliev, “Investigation of the stability of the Bubnov-Galerkin method for nonstationary problems”), published in *DAN*, vol. 157, No. 1, 1964, the following corrections must be made.

- 1) In the statements of Theorems 1, 2, 3, and 5, the requirement that the coordinate system be normal must be replaced by the requirement that it be orthonormal.
- 2) In Theorem 3, stability may be asserted not on an infinite interval, but only on any finite interval of time, and the condition

$$\int_0^{\infty} t^2 \|f\|^2 dt < +\infty$$

turns out to be superfluous.
